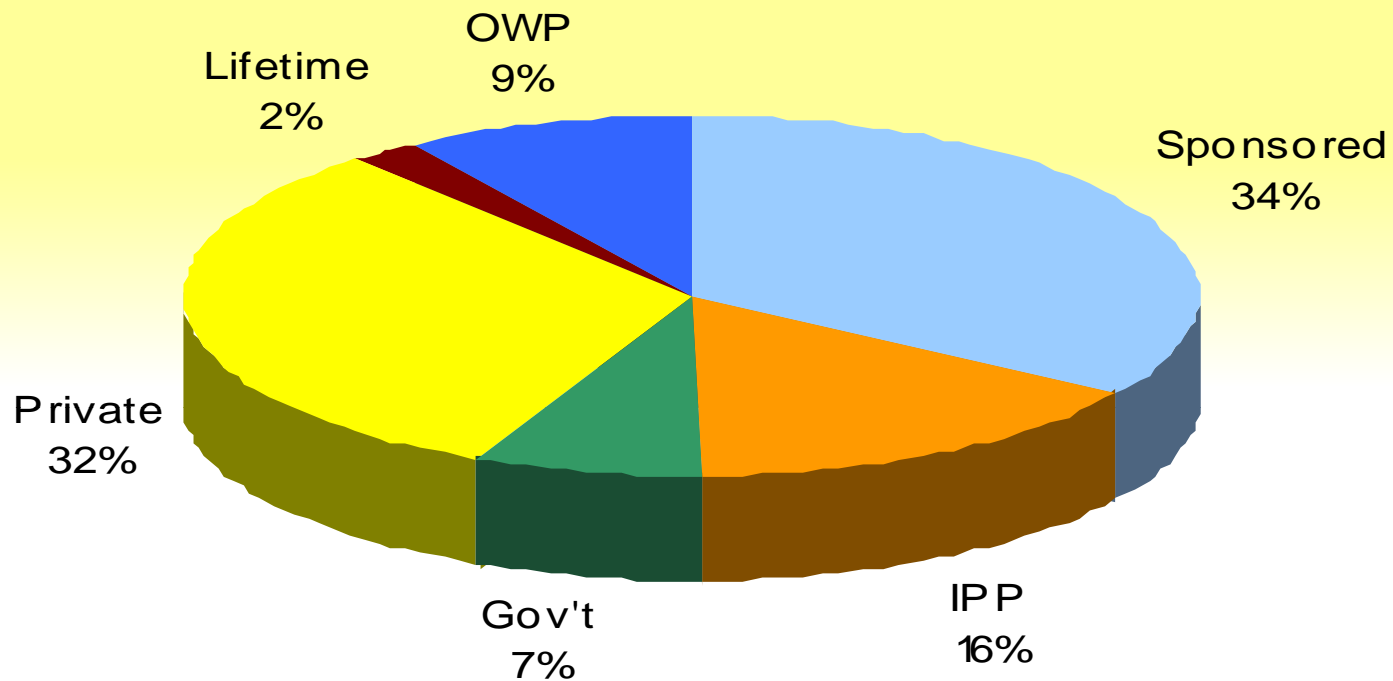

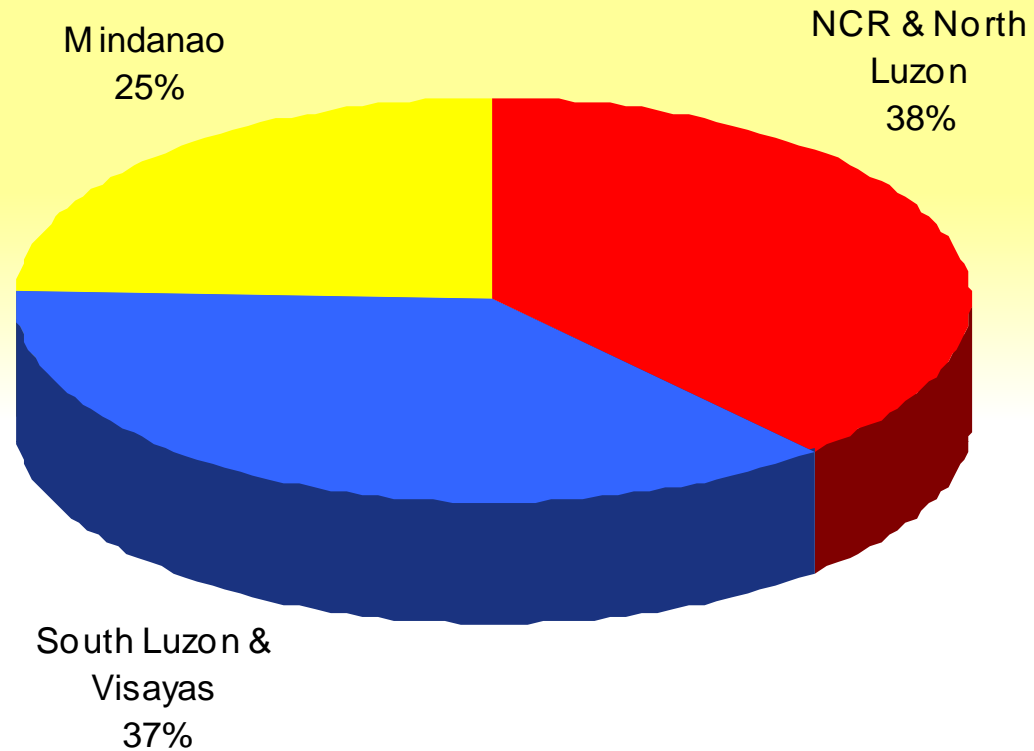
Membership (by Sector)

As of December 31, 2011



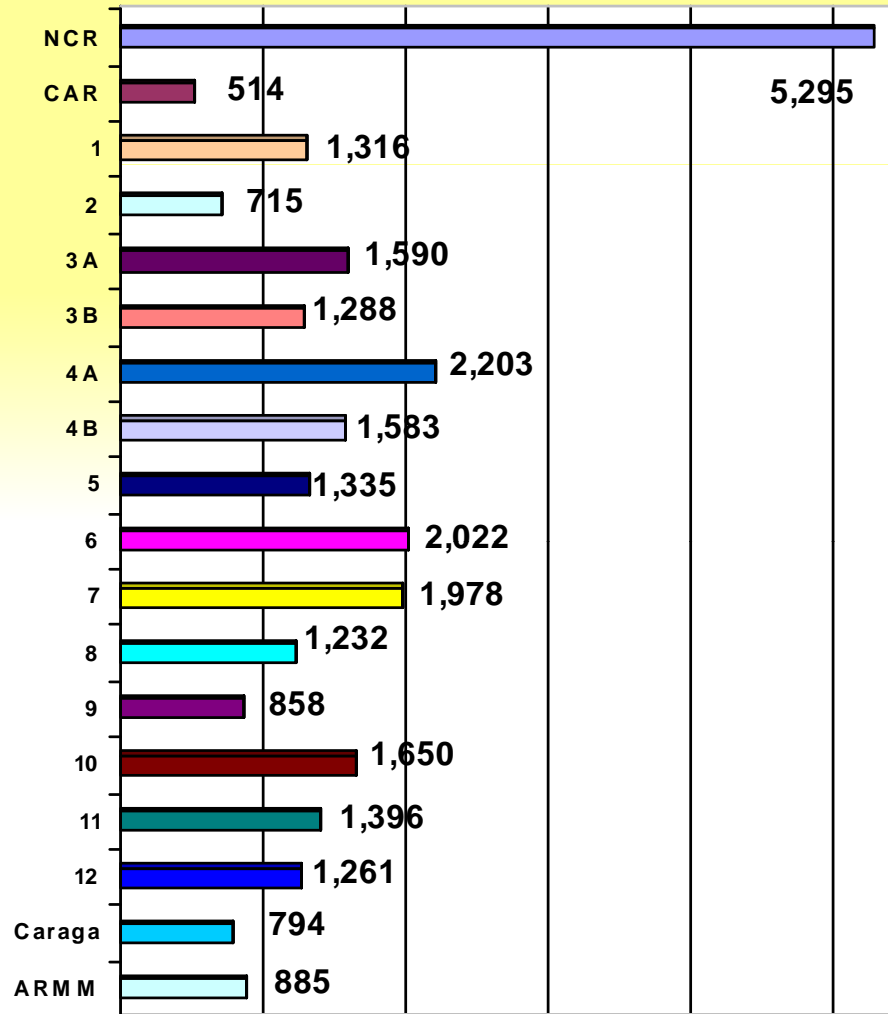

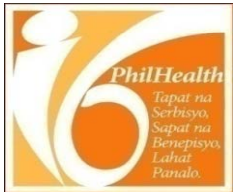


Registered Members (by PhRO)

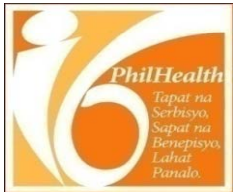

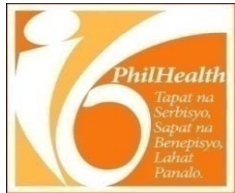


Premium Collections (by Sector)

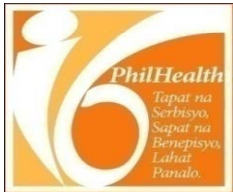

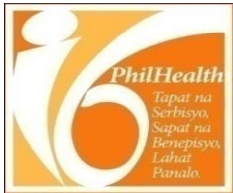
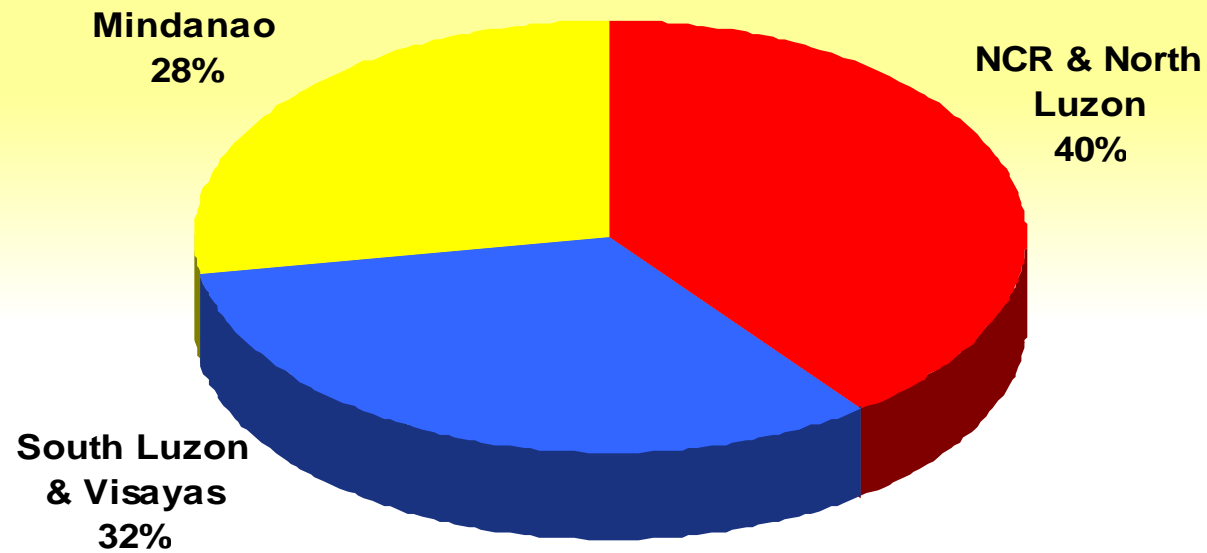
(Number of Claims Paid Per Sector)

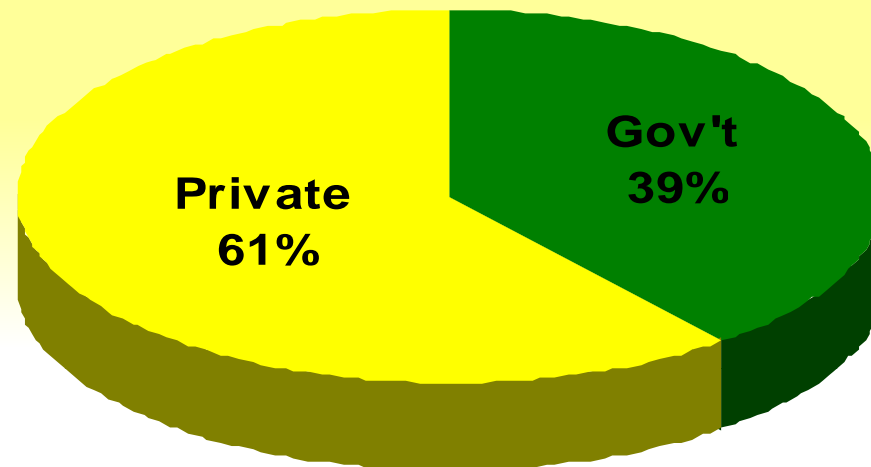
