

Top Performer: Bataan LHIO achieves 100% provider accreditation for Konsulta

ATAAN Local Health Insurance Office (LHIO) Head Edmond Manuel presented the innovations and best practices in achieving the **100%** accreditation of Konsulta Providers in the Province of Bataan during the Marketing Summit for Konsulta held at Clark, Pampanga on June 28-29, 2022. PCEO Atty. Dante A. Gierran, EVP and COO Atty. Eli Dino D. Santos, Area 1 VP Walter R. Bacareza, PRO III AVP Edgardo F. Faustino, ABM-A Dr. Rowena Z. San Mateo, ABM-B Arlan M. Granali, officers and staff from the Central Office and PhilHealth Regional Offices (PROs) were present during this first face-to-face gathering in two years, to showcase the

milestones in the implementation of PhilHealth Konsulta or Konsultasyong Sulit at Tama nationwide. PROs XII, V, and CAR also shared their practices and innovations in their respective areas.

The PhilHealth Konsulta is the expanded primary care benefit package first launched in 2021 as part of the implementation of the Universal Health Care Law. The PhilHealth Konsulta package covers primary health services including initial and follow-up primary care consultations, health screening and assessment and access to selected diagnostic services, and medicines.

During the said Marketing Summit, Manuel highlighted that the road to the full implementation of the Konsulta program was not an easy path, and the challenges along the way provided opportunities to discover new ways to enlist the support and participation of health care providers, members, and other stakeholders. "Strong and measurable support from the local chief executives (LCE) and local government units (LGU) as one of the champions of the Universal Health Care and Konsulta programs will be very critical to ensure that potential health care providers in the covered areas shall continuously provide the primary care services needed by the constituents who are covered by PhilHealth", Manuel emphasized.

It was further emphasized that the Konsulta benefit package is not only a necessity for every Filipino but also serves as a significant financial incentive for accredited health care facilities to augment their resources through capitation. Manuel also cited the ABC strategy to make PhilHealth Konsulta's implementation easier to both partners and stakeholders: A-ccreditation, B-enefits, and C-apitation.

During the **Accreditation** stage, the PhilHealth team engaged the support of the LGUs, LCEs, and targeted health care providers (e.g. rural health units) to ensure that there is at least one accredited Konsulta provider per municipality and city in Bataan. The PhilHealth team conducted close and consistent coordination, assistance, and various orientations and discussions on the accreditation process, program coverage, self-

assessment tool (SAT), eKonsulta, IT system support needed, and payment procedures.

Under the **Benefits**, the PhilHealth team emphasized that the Konsulta is a win-win program for both the health care providers and members who will avail of the services. Since health care providers were already providing the services to the public, payment for the Konsulta benefits in the form of capitation shall serve as augmentation to their current budget for the provision of these services. On the other hand, PhilHealth members who will be registered as Konsulta beneficiaries in their preferred accredited Konsulta facilities can avail of the services such as medical consultations, laboratory tests, and maintenance medicines at free or minimal cost. Thorough information and education campaign, and orientation activities

on the benefits and registration procedures are currently being conducted to all PhilHealth members. A PhilHealth member may register to his/her preferred or nearest Konsulta provider through the facility, LHIOs, or the PhilHealth Member Portal which can be accessed through www.philhealth.gov.ph

On the payment of **Capitation**, he developed a system of computation for easy targeting and monitoring of LGUs, LCEs, and Konsulta providers on the registration of members and required capitation. Moreover, LHIO-Bataan also conducted various "Lakbay-Aral" activities wherein other LHIOs and support offices in Central Luzon have learned the step-by-step procedures of Konsulta implementation from accreditation, deployment of system, training, registration of members, and payment.

As of June 2022, Bataan has reached the 100% target in the accreditation of Konsulta Providers, having a total of 24 accredited providers for this year with 20 Rural Health Units (RHUs) and 4 hospitals, thus every municipality or city has at least one Konsulta provider where a member can avail of the needed primary care services. The following are the accredited Konsulta Providers in Bataan:
